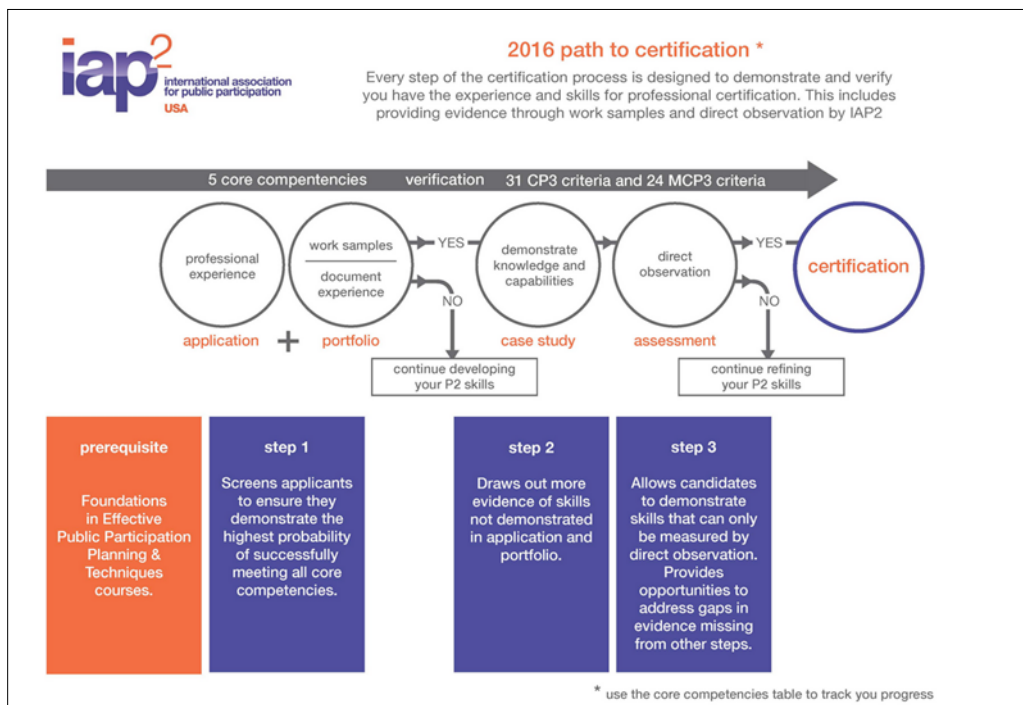

## IAP2 Professional Certification

After two years of development, the IAP2 USA Affiliate held a pilot of the [Professional Certification Program](#) in September 2015 in Portland, Oregon. The assessment process was developed by a Task Force of IAP2 members from USA, Canada, and Southern Africa affiliates in consultation with IAP2 membership. The program offers two levels of certification: Certified Public Participation Professional (CP3) and Master Certified Public Participation Professional (MCP3). Credentials are awarded upon completion of a three-step assessment based on [5 Core Competencies](#) developed through the membership consultation process. The IAP2 Federation acknowledges the leadership of IAP2 USA and extends its sincere appreciation to the task force members for this great work and contribution to the practice.

**ORGANISATION OF THE YEAR 2015**

**St. Vrain Valley Schools**

*Embracing Public Participation: A whole systems approach to organizational change*

St. Vrain Valley Schools, Colorado's seventh-largest school district, serves over 32,000 students in 53 schools across eight municipalities in Colorado's Front Range region. In 2008, an 8-year plan was created to combat the severe issues caused by decades of budgets cuts, unfunded reform laws, and a growing population in need of assistance. Today, as the eight-year mark approaches, the St. Vrain Valley School District has completely transformed itself from a low-performing and widely criticized school district into a national model of institutional excellence.

**People with Disability Australia**

*NDIS Citizens Jury – Citizens Jury for the National Disability Insurance Scheme*



In 2013, the National Disability Insurance Scheme (NDIS) was created through the National Disability Insurance Scheme Act 2013 and its

coordinating agency the National Disability Insurance Agency (NDIA) established. While there were many reviews of the scheme the voice of people with disability was absent in key places. People with Disability Australia (PWDA) proposed to the NDIA, a Citizens' Jury as an appropriate way to develop a grassroots scorecard on the NDIS which allowed ordinary people paying for the NDIS to deliver a verdict based on direct personal witness from people in the trial sites.

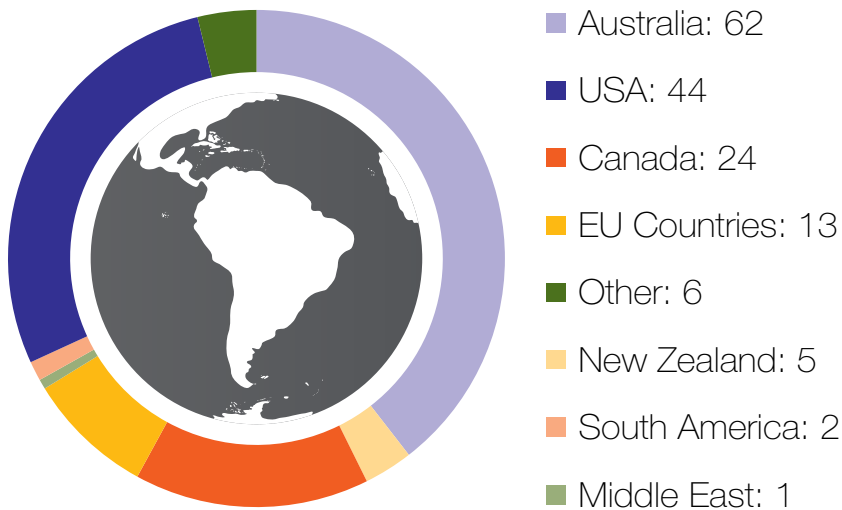
## IAP2 Spectrum Review

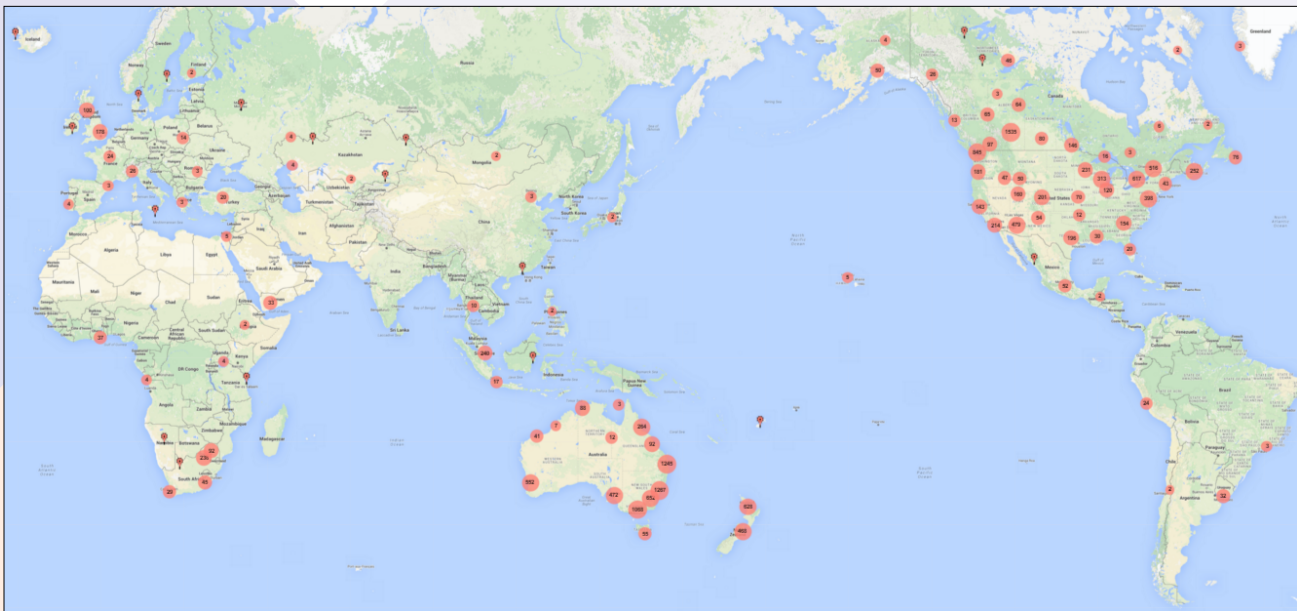

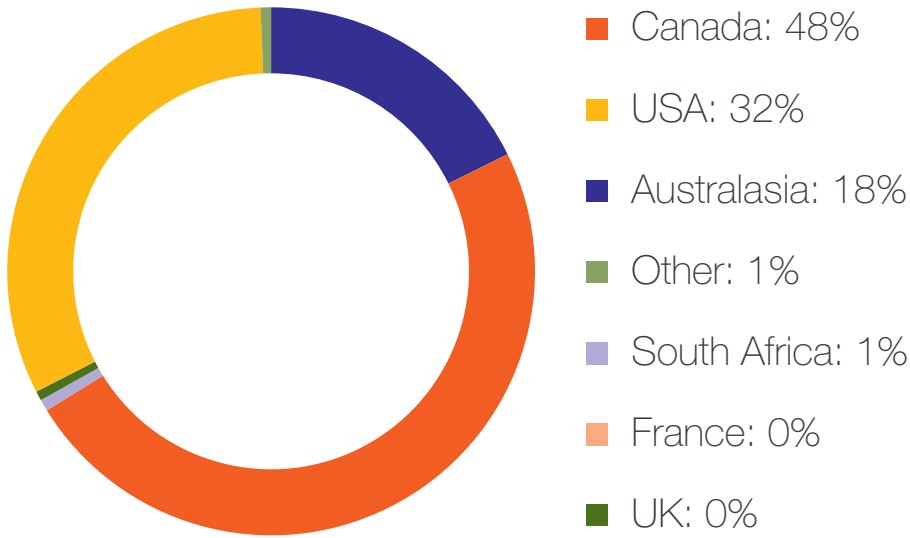
### Foundations in Public Participation and Emotion, Outrage and Public Participation

IAP2 carries out its mission to advance and extend the practice of public participation by organizing and conducting professional development activities to serve the learning needs of members around the world. The [Foundations in Public Participation](#) and [Emotion, Outrage and Public Participation](#) are the two flagship IAP2 courses. In 2015, 5,179 training days were delivered by trainers licensed to IAP2 Federation throughout Australia, New Zealand, Canada, Poland, United States, and the United Kingdom. To date, more than 17,000 individuals have taken IAP2 training.

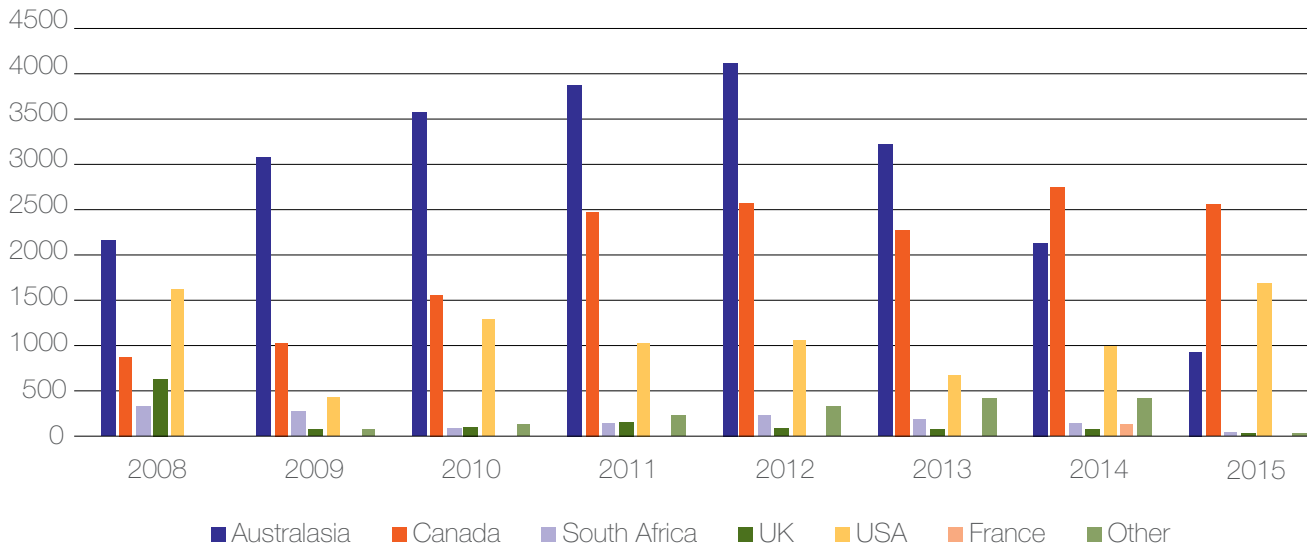

## IAP2 AUSTRALASIA TRAINING – CERTIFICATE IN ENGAGEMENT

The new IAP2 Australasia *Certificate in Engagement* program offers training for community and stakeholder engagement practitioners across Australia and New Zealand, in addition to the IAP2 Federation training programs mentioned above. This new course has been designed with participant flexibility in mind and consists of a limited number of core modules and an evolving number of electives which will grow and change as the market develops and matures. ## Notes to Financial Statements

### **FUNCTIONAL REPORTING OF EXPENSES**

For the year ended December 31, 2015, the costs of providing the various programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

### **SUMMARIZED PRIOR-YEAR INFORMATION**

The financial statements include certain prior-year summarized comparative information in total but not net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with generally accepted accounting principles. Accordingly, such information should be read in conjunction with the Organization's financial statements for the year ended December 31, 2014, from which the summarized information was derived.

### **RESTRICTED AND UNRESTRICTED REVENUE**

Contributions received are recorded as increases in unrestricted, temporarily restricted, or permanently restricted net assets, depending on the existence and/or nature of any donor restrictions.

### **RECLASSIFICATIONS**

Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

Currently these reserve funds have not been set aside in a separate investment account but are included in the liquid assets savings account.



# IAP2 AFFILIATE ACTIVITIES REPORT

## Membership

IAP2 Membership has grown over the last 5 years since the formation of the Federation of Affiliates in 2011 with 1,937 members to more than 4,000 in 2015, doubling our ranks in a short period of time. This extraordinary success is due in part to the dedication and countless hours of volunteer and staff time, local delivery of an expanded offering of member benefits, and programming tailored to the particular needs of members.

## Highlights of Affiliate Activities

The following IAP2 Affiliates have provided activity highlights for the calendar year ending December 31, 2015.

### IAP2 AUSTRALASIA

In June 2015 the IAP2 Core Values were recognized by more than 700 councillors, general managers and chief executives from Local Government across Australia (and some from New Zealand) at the National General Assembly of Local Government. It was resolved *“that the National General Assembly acknowledges the seven core values of public participation as leading positive practice for involving citizens in democratic decision making and request the Australian Government demonstrate the use of these principles in the development of public policy.”* The IAP2 Core Values were listed and support for this motion was overwhelming, which resulted in the unanimous resolution.

IAP2 Australasia hosted a series of Masterclasses in Brisbane, Sydney, Melbourne, Perth, Adelaide and Hobart with Anne Leadbeater OAM, an independent national consultant who specialises in disaster recovery and community resilience.

Two groups of 12 staff from the Resettlement Department of the Cambodian Ministry of Economy and Finance, visited Melbourne to undertake the Certificate in Engagement and learn more about engagement practices in Australia. The trip was arranged through the Asian Development Bank as part of a larger program that sees Department staff visiting a number of countries to learn how they can improve their practices.

This year IAP2 Australasia extended training opportunities with the development of the *Advanced Certificate in Engagement*, along with *Pathways to Advanced Engagement Practice* module, a training link between the *IAP2 Foundations in Public Participation* (formerly the Certificate program) and the *IAP2 Australasia Certificate in Engagement*.

In 2015, IAP2 Australasia realized a significant increase in event attendance due to the strength of local networks and an increased understanding of consumer demographics and member needs. More than 1,400 individuals participated in an IAP2 event during the year, a two-fold increase from the prior year.



### IAP2 CANADA

In 2015, IAP2 Canada made significant developments with the addition of two regional chapters. The new Atlantic Chapter hit the ground running with a reception and training session in St John's, Newfoundland and Labrador. There were also events for members in Halifax NS and Dieppe NB, including a French-language course in IAP2 Foundations of Public Participation. The St. Lawrence Chapter/Section Saint-Laurent became an officially multilingual chapter and a translator was hired to render IAP2's communications and promotional material into French.

On a federation-wide level, IAP2 Canada took an important leadership role in coordinating discussions on the future of the IAP2 Spectrum as well as participating in the Certification Task Force along with IAP2 USA and South Africa.

IAP2 Canada made important advancements in specific sectors of P2, setting up an Indigenous Engagement Subcommittee and Advisory Panel and launching the Energy Community of Practice.

In addition to all of that, there were many local chapter events, monthly learning webinars, and the second annual Core Value Awards specific to IAP2 Canada. A few of the topics covered in the webinars and chapter events were: Research and Practice, Social Media and P2, Thinking Beyond the Open House: Public Participation is More Than Donuts & Coffee, and Designing As If Stakeholders Matter.




**IAP2 INDONESIA**

IAP2 Indonesia held monthly potluck discussion for affiliate members about public participation and networking events with stakeholders including the government bodies, legislative, private sector and civil society.

IAP2SA hosted a presentation to The National Transport Forum (NTR) on training offerings and best practice for projects that involve public participation. IAP2SA team with Ken Smith, Tim Hart, Erika du Plessis, and Nomi Muthialu attended the presentation at DBSA office, Midrand, Johannesburg.

Ongoing engagements with DBSA and MCI Group continue on plans to host the Voice for Change: Stakeholder Engagement Summit in mid-2016 as well as with the IAIAA regarding support and participation for their National Conference.

Training offerings this year included a successful training session in February 2015 with the IAIAKZN Branch which was led by Erika du Plessis, and the Foundations in Public Participation training was held by Golder Associates under Antoinette Pietersen in October 2015.

## IAP2 USA

In 2015, the main activities held for members were the IAP2 North American Conference, the Skills Symposium, the Annual General Meeting, online webinars, and periodic chapter events.



The conference held in Portland, Oregon was jam-packed with more than 350 people and 50+ sessions, plus tours of the "Birthplace of P2," four keynote speakers, and the IAP2 North American Core Values Awards Gala.

This year IAP2 USA supplemented the annual North American conference with the Skills Symposium held in Minneapolis, Minnesota. The event featured five days packed full with a wide range of workshops exploring skills, tools and techniques that support effective public participation.

Governments across the country are adopting public participation ordinances and creating guidelines to better engage their residents in making decisions. To continue to encourage this trend, IAP2 USA has created a new government membership that offers benefits for all employees.



Webinars and chapter events were held during the year on many topics including: Core Values Awards Winners: Leaders in Research, Audience Response Systems in an Emotional Setting, A Framework for Community Engagement, and Lead More, Control Less.
