COURSE OVERVIEW

Learn to cultivate informed and thoughtful public discussion in this age of polarized debate. This course introduces engagement methods used for policy issues around the globe: Citizens Assemblies, Deliberative Polling, the 21st Century Town meeting. In each, people from different walks of life are convened to learn about an important topic, deliberate on options for action, make proposals to governments and leaders, and generate ideas for change. You will also explore, and apply to your own work, key ingredients of these processes, including developing discussion content and questions, as well as outreach strategies to involve large numbers of diverse participants.

Participants completing this course can:

- Begin to design meetings that emphasize dialogue and deliberation among participants
- Draft powerful discussion questions that solicit focused participant input
- Describe approaches for supporting participant learning
- Identify and address barriers to participation
- Explain various approaches for participant recruitment that is demographically representative of communities most impacted by the issue
- Compare and contrast the theory and practice of the Citizen Assemblies,
 Deliberative Polling and 21st Century Town Hall
- Apply aspects of deliberative dialogue methods to your own work
